RECURRING CREDIT CARD POLICY

Recurring Payment Authorization gives Kim Hohman's DanceWorks, LLC. To charge the indicated credit card for services provided and all applicable costume and tuition charges. There are two options that you can choose from on how you would like the recurring payment to happen. If you would want to terminate the recurring billing process you must submit a cancelation notice in writing 30 days prior to the last transactions and arrange for an alternative method of payment. By using the recurring payment process it will allow your account to be up to date at all times.
